OVERVIEW OF THE APPLICATION SUPPORT GUIDE



This application support guide is designed for proponents of Inuit-specific **emergency shelters** for Inuit women, gender-diverse individuals and their families.

This application support guide is available in English and Inuktitut. However, when applying for an emergency shelter on the CMHC website, applications can only be submitted in English and French.

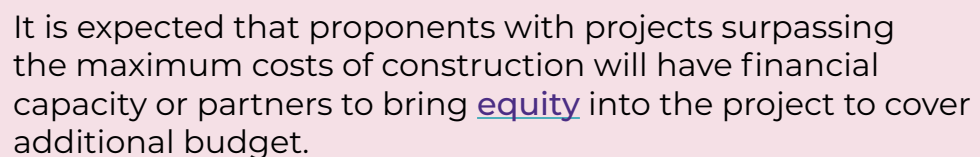
- ▶ The [Indigenous Shelter and Transitional Housing initiative](#) is a joint project by Canada Mortgage and Housing Corporation (CMHC) and Indigenous Services Canada (ISC), offering construction and operational funding for shelters and transitional housing supporting Indigenous peoples escaping gender-based violence, including women, 2SLGBTQQIA+ people and their children.
- ▶ The application process is for both the construction and operating funding. Selected applicants will receive capital funding from Canada Mortgage and Housing Corporation for the construction of the facility and operational funding from Indigenous Services Canada to support its operations. Start up funding will be delivered through Indigenous Services Canada a year in advance to the operations of the facility.



CMHC wants to work with you! CMHC strongly encourages Inuit proponents to get in touch with their team of Housing Solutions Specialists **to discuss potential or in-progress applications**. They are there to provide support to applicants through every step of the application process. Proponents can have components of their application reviewed by CMHC at any time; it does not need to be at final submission that CMHC has the first opportunity to review the application.

- ▶ In January 2021, the Government of Canada [announced](#) a commitment to fund the construction and ongoing operation of new Inuit-specific shelters for women, 2SLGBTQQIA+ people and their children located across Inuit Nunangat and in urban centres.
- ▶ Construction funding is provided by CMHC, whether it's for new construction or building conversion from a non-residential use to a shelter.
 - ▷ CMHC will provide a maximum of \$3.48 million per shelter in Provinces across the country, and a maximum of \$7.2 million per shelter in Territories and Inuit Nunangat.
 - ▷ The allocation is in the form of a **forgivable loan** for the construction of new shelters or for the acquisition and rehabilitation of buildings for conversion to shelters. Selected proponents will enter into a loan agreement with CMHC for a 20-year period. **The full amount of the forgivable loan will be earned in 20 equal annual amounts**, provided the terms and conditions of the agreement continue to be fulfilled.

- ▶ Indigenous Services Canada (ISC) will provide:
 - An average annual allocation of \$800,000 to operate shelters in Provinces across the country
 - An average annual allocation of \$1 million to operate shelters in Territories and Inuit Nunangat
- ▶ Funding for capacity building involves providing support to shelters and their staff through training forums, gatherings and development and distribution of resources and research.

How do I apply?

- ▶ Apply for funding under the [Indigenous Shelter and Transitional Housing initiative](#) through the online [CMHC Application Portal](#). **It is through this single application that projects are assessed for construction funding (from CMHC) and operational funding (from ISC).** You will upload all mandatory or supplementary documentation through this portal. You can also work on your application gradually, saving it step-by-step. Because your application progress is saved in the CMHC system, you will be able to make changes to your application based on CMHC feedback without having to start the application over.
- ▶ Project proponents with weak internet connection are advised to prepare their application manually and submit their application through paper mail to their regional [Housing Solutions Specialist](#).

Note: If you have internet connection issues, an offline PDF application can be made available upon request. Please contact your regional [Housing Solutions Specialist](#) to request an application.

How does the selection process work?

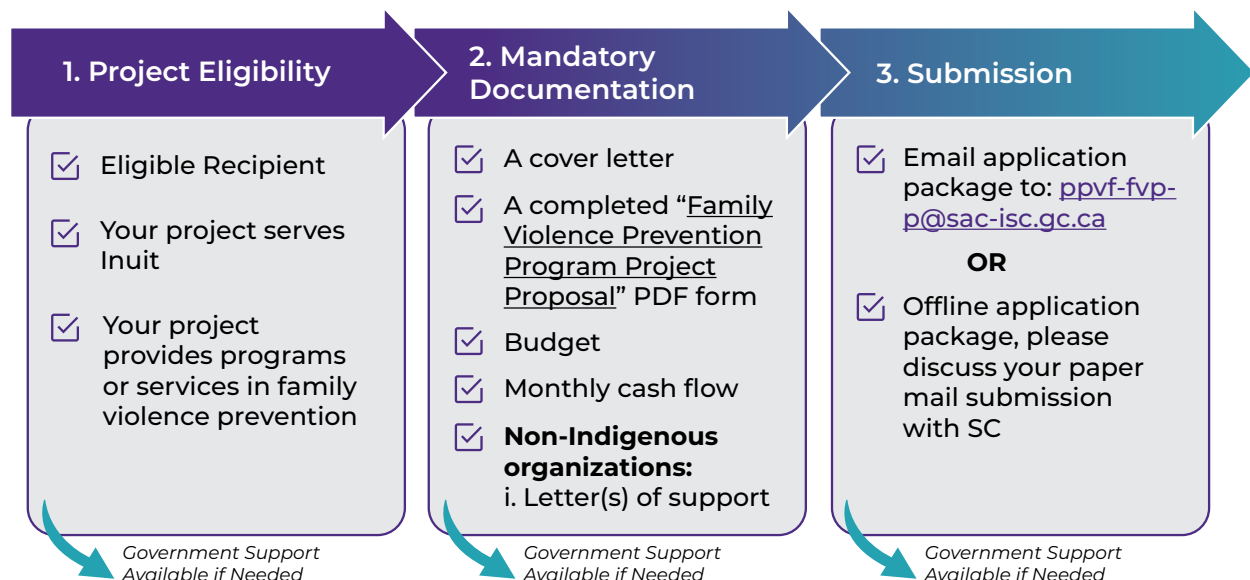
- ▶ CMHC is currently experiencing a gap in applications for projects led by Inuit and Indigenous 2SLGBTQIA+ groups as well as urban groups. During the next review and selection phases, applications for projects from these groups will be prioritized to reduce the current gap being observed.

DEFINITIONS

Shelter

Defined as a facility providing temporary shelter and emergency services to support women and children and/ or 2SLGBTQQIA+ people facing gender-based violence. They function in a crisis capacity with short stay duration.

Transitional housing/Second stage housing

Housing that is intended to offer a supportive living environment for its occupants in need for additional time and support to heal from their trauma, offering them the experience, tools, knowledge and opportunities for living independently and violence-free. It is considered an intermediate step between emergency shelter and supportive housing, and has limits on stay duration. **Transitional housing and second stage housing under this initiative are interchangeable terms that designate the same housing purpose.**

Units

For the purpose of shelters, a “unit” is a room, regardless of the number of beds in the room that shares kitchen and/or bathroom facilities with other rooms in the shelter.

For the purpose of transitional housing, a “unit” is in the form of a self-contained unit. A self-contained unit is a facility that contains cooking, eating, living, sleeping and bathroom facilities.

Beds

For the purpose of shelters, a “bed” is an individual bed in a shelter program that supports overnight sleeping accommodations.

2SLGBTQQIA+

Two Spirit, Lesbian, Gay, Bisexual, Transgender, Queer, Questioning, Intersex, Asexual, and others.

This term is intended to include non-binary people and people with diverse sexualities, and as an explicit reminder that gender-diverse people's needs must equally be taken into account. The "+" at the end of "2SLGBTQQIA+" is a way of being inclusive, honouring and celebrating how languages are expanding and offering choices for sexual and gender diverse individuals to identify.

Easements

A right that lets someone use your land for a specific purpose.

Equity

Funds provided in return for a share in the ownership of the project.

Leased (land)

Take (property) on lease; rent.

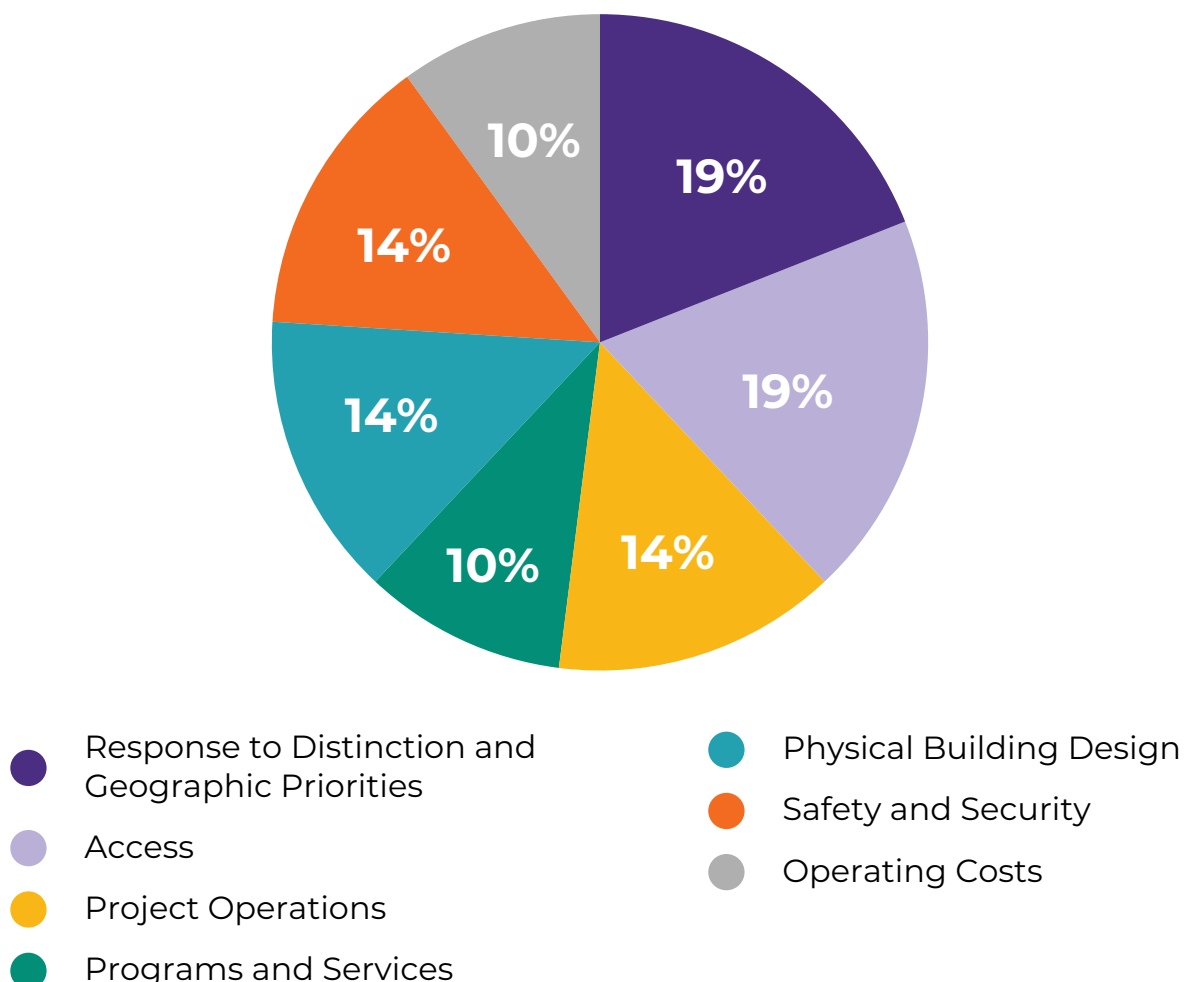
EVALUATION CRITERIA

How will proposals be evaluated?

Proposals will be reviewed and assessed with input from representatives of Inuit organizations and federal partner organizations (e.g., CMHC, Indigenous Services Canada, Pauktuutit, and Crown Indigenous Relations and Northern Affairs Canada).

Proposals are assessed in 7 distinct evaluation categories as follows:

Tick the box next to each statement that applies to your project.

1) Project Purpose

- ☐ Project purpose is for the creation and/or operation of new shelter spaces intended for Inuit women, children and 2SLGBTQQIA+ escaping family violence.

2) Proponent Profile

- ☐ Project proponent is an Inuit organization, land claim organization, or government.
- ☐ Project proponent is a non-Inuit organization or government. Project Application identifies the Inuit community(ies) that will be served, and demonstrates support from Inuit local authorities and Inuit led services.

Ineligible Projects:

- ▶ Shelters serving men are not eligible for funding under this program. Contact CMHC to discuss different funding options.
- ▶ Shelters for individuals coming out of the correctional system are not eligible for funding under this program. Contact CMHC to discuss different funding options.

ISC's Family Violence Prevention Program Eligibility Checklist

Applicants must **also** be eligible to receive Shelters operations and capacity building funding from ISC's Family Violence Prevention Program.

ELIGIBLE COSTS AND EXPENSES

Construction Costs (Canada Mortgage and Housing Corporation)

CMHC will provide funding of up to 100% of a project's total eligible capital costs in the form of a forgivable loan.

Eligible Capital Costs (CMHC)

- ▶ Land acquisition
- ▶ Construction, acquisition and rehabilitation, or conversion of facilities
- ▶ Soft costs (i.e. architect, engineer, or project management fees, other consultants' fees, the cost of development fees and/or permits, taxes, course of construction insurance, interest charges on interim financing, legal fees, audits, enrolment in recognized warranty programs if applicable, and advertising costs for tenders.)
- ▶ Accessibility for persons with disabilities
- ▶ Hard furnishings required for the operation of the project (i.e. appliances, built-ins, non-movables and major pieces of maintenance equipment.)
- ▶ Appropriate building security
- ▶ Children's play areas
- ▶ Landscaping

Operating Expenses (Indigenous Services Canada)

The Family Violence Prevention Program (FVPP) funds the day-to-day operations of a network of emergency shelters and transitional (second stage) housing to improve the safety and security of Indigenous women, children, families, and 2SLGBTQIA+ people across Canada, including Inuit, Métis, and urban communities.

Eligible Operating Expenditures

- ▶ Salaries and employee benefits
- ▶ Professional fees (contracts)
- ▶ Honoraria for Elders
- ▶ Domestic travel and transportation
- ▶ Costs related to the purchase, ownership, and maintenance of vehicles, including insurance as applicable, to support operation of the facility*
- ▶ Meetings
- ▶ Hospitality
- ▶ Training and development
- ▶ Equipment
- ▶ Rent and utilities
- ▶ Translation and communications
- ▶ Materials and supplies
- ▶ Volunteer participation expenses
- ▶ Audits and evaluation
- ▶ Legal and banking fees
- ▶ Insurance
- ▶ Overhead administration costs**
- ▶ Direct client costs*

- ▶ Operations, minor maintenance, upgrading and repairs to facilities not exceeding \$50,000*
- ▶ Crisis line*
- ▶ Off-hour emergency services*

* eligible expenses for Shelters operations only; these expenses are ineligible for Capacity Building funding.

to be eligible for capacity building funding, **overhead administration costs cannot exceed 15% of the contribution.

Eligible Overhead Administration Costs

- ▶ Payroll administration fees
- ▶ Office supplies and equipment
- ▶ Telephone and IT support services
- ▶ Human resource services and recruitment

Other expenditures may be considered eligible based on direct link to the activity and are subject to FVPP review and approval.

Ineligible Operating Expenditures

- ▶ Purchase of capital assets with a market value above \$5,000 (unless pre authorized in writing)
- ▶ International travel (unless pre-authorized in writing)
- ▶ Deficit recovery
- ▶ For-profit initiatives and investments
- ▶ Capital costs (except minor maintenance)

Start-Up Costs

Start-up costs are one-time expenditures to begin operations, i.e., the goods and services necessary to furnish and set up the facility. **This includes furniture, computers and software, vehicles, and other items that will not be purchased every year.**

Please include an itemized list detailing what the start-up costs are for and the amounts **as an attachment in the online application STEP 9-Attachments**. The estimated subtotal for start-up costs is requested in the **Mandatory Application Worksheet – Appendix A- Annual Operating Budget Worksheet line 24**.

Note that there is separate funding for start-up costs, which is approximately 50% of the average annual allocation for the type (shelter or transition home) or location (southern vs northern or remote geographical areas).

Approximate Funding for Start-Up Costs:

- ▶ \$400,000 for shelters in Provinces across the country
- ▶ \$500,000 for shelters in Territories and Inuit Nunangat
- ▶ \$250,000 for transition homes across the country

A class “C” estimate is prepared when a project is at the “Preliminary Design” stage. Typically, there are four categories of estimate – D, C, B, and A – with D being the least accurate and A being the most accurate. A class C estimate is when the costing is estimated based on a conceptual design and/or comprehensive list of project requirements, this estimate is usually detailed enough to allow for investment decisions.

- ☐ Construction Schedule showing milestones and estimated time to complete the project

Supplementary Documentation

- ☐ Itemized list of Start-Up Costs (from Mandatory Application Worksheet- Appendix A- Annual Operating Budget Worksheet **line 24**)

All of these documents will be uploaded and submitted in [STEP 9 - Attachments](#) of the online application.

Annual Operating Budget Worksheet Guide

The Annual Operating Budget Worksheet, found in Appendix A of the Mandatory Application Worksheet, will inform the selection committee of your funding request for the operating expenses of the shelter: the annual, recurring costs to run the shelter.

Estimates provided for the operating budget should **only reflect the ongoing, annual operational costs** for the project and **refrain from including one-time expenditures specific to the purchase of various goods and services necessary to furnish and setup the facility**. These [start-up costs](#) have a designated line item in **line 24** of this worksheet. Please include an itemized list detailing what the start-up costs are for and the amounts **as an attachment in the online application STEP 9 - Attachments**.



Applicants must provide an annual operational budget that is specific to their proposed facility.

A feasibility assessment will be completed to determine whether the operating budget is reasonable and realistic according to the established funding levels.

Annual Operating Expenses and Revenues

1. **Staff Salaries and Benefits** (not all may apply)
 - Proposals should clearly demonstrate an understanding of shelter operations through staffing. This includes providing realistic and reasonable staffing breakdowns for the shelters in accordance to their size (whether it be small, medium or large), hours of operation, off-hour shifts, and expected volume of intake.
 - For reference, the standard size classifications for shelters can be found in table 1.1 Standard Shelter Size Classification below. The figures are reflective of the typical size classifications found among the existing network of shelters supported by Indigenous Services Canada and are solely meant to be a point of reference for proposal development.

Table 1.1 Standard Shelter Size Classification

Shelter Size	Number of Units	Number of Beds
Small Shelter	1 to 2 units	1 to 5 beds
Medium Shelter	3 to 5 units	6 to 13 beds
Large Shelter	6+ units	14+ beds

Figures on shelter size classification are for example only and reflect the standard ranges found among the existing network of shelters supported by Indigenous Services Canada.

2. **Professional Fees** (including translation)
 - Costs to hire professional consultants including lawyers, accountants, architects, engineers, site surveyors, etc.
3. **Honoraria**
 - An honorarium is a token payment made to bestow recognition to an individual for services they perform, for which payment is not required. Typically, an honorarium is issued when custom or propriety forbids a price to be set. Therefore, payment to the recipient is at the discretion of the payer.
4. **Staff and Development Training**
 - Such as professional development expenses.
5. **Small Appliances, Furniture, Equipment** (anything moveable)
 - Includes small kitchen appliances (e.g. kettle, toaster), computer equipment.
 - NOTE: Do not include one-time expenditures specific to the purchase of various goods and services necessary to furnish and setup the facility. Account for these items in **line 24** of this worksheet.
6. **Resident Expenses** (e.g. food, bedding, towels, soaps, personal incidentals, transportation to and from shelter)

365 days x \$_____ expenses x _____ nbr residents

- The application form provides a general formula for calculating annual Resident Expenses, where the first blank refers to **the total daily cost** of consumables per resident (\$), and the second blank refers to the maximum number of residents (nbr residents) the shelter can house at one time .
- Considering bedding and towels may be one-time expenses, and that residents may not be using transportation every day, the following alternative formula may be used. The calculation and rationale can be provided in the Description column.

(365 days x \$_____ (daily food, personal hygiene) expenses x _____ (maximum # of residents at a time)) + _____ (total towel & bedding expenses per year) + _____ (total resident transportation expenses per year)

7. **Supplies** (e.g. cleaning, linen, personal protective equipment)
 - Includes cleaning and kitchen supplies, personal protective equipment for staff and residents (if needed) such as masks, eye protection, face shields, gloves and/or gowns.
 - If all linen expenses were already accounted for in line 6, there is no need to include them in line 7.
8. **Property Taxes** (excluding water and sewer) if applicable, provide an estimate
 - Taxes generally paid to a municipality/local government to pay for shared services like garbage collection, municipal infrastructure, etc.
 - Utilities are not included in this line item.
9. **Insurance** (e.g. fire, liability, etc.)
 - Annual total insurance expenses on the property.
10. **Maintenance** (e.g. minor repairs, painting, landscaping, other)
 - Estimated annual maintenance expenses.
11. **Replacement Reserve** (0.50% of total construction costs)
 - A separate account funded by annual contributions out of the operating budget to pay for large property expenses. This fund exists to deal with long-term major repairs and unexpected expenses.
 - You will find in [Appendix 1](#) the list of items that can be paid out of a replacement reserve account.
 - For this process, the Replacement Reserve will be 0.5% of the total construction costs of the project as indicated in online application **STEP 7 - Construction Costs line 26 - Total Shelter Capital Costs**. For example, if the total construction costs of a facility is \$6 million, then \$15,000 would be set aside **each year** in the Replacement Reserve. In time, this will allow for enough funds to accumulate in order to pay for major repairs or emergency repairs.
12. **Utilities** (e.g. heating, light and power, garbage, snow removal, water and sewer)
 - Expenses paid to organizations supplying electricity, gas, water, sewage or other services.

13. **Computer/IT Services, Internet Access, Software Licenses**
→ Includes wifi, human resources softwares, etc.
14. **Security Equipment Operation** (e.g. monitoring)
→ Examples include alarm and video surveillance systems, access control systems, outdoor lighting, etc.
15. **Transportation Costs** (vehicle, insurance, maintenance, fuel, driver)
→ Costs related to the purchase, ownership, and maintenance of vehicles to support operation of the facility are eligible. This includes auto insurance as applicable.
→ If any portion of resident transportation expenses were accounted for in line 6 of this worksheet, do not include them again in this line item.
16. **Other Operating Costs** (e.g. client needs assessments, library and resources, off hour emergency services, etc.)
→ Any other annual operating costs other than those previously mentioned, excluding programming and services (accounted for in line 17 below).
→ Client needs assessments could include services from specialists who are not staff members.
17. **Costs for Programming and Services**
→ Includes ongoing materials and supplies needed for programming and services. Examples include cooking class food, special tools, art supplies, Instruments.
→ Do not include:
 - Salaries (accounted for in line 1 of this worksheet);
 - Small appliances, furniture, equipment (accounted for in line 5 of this worksheet);
 - Cleaning supplies (accounted for in line 7 of this worksheet);
 - Large appliances (accounted for in online application STEP 7- Construction Costs line 20).
18. **Administration – Audit**
→ Fees associated with an official financial inspection of an organization's accounts, typically conducted by an independent body.

19. **Administrative Costs** (for the management of the agreement)
 → Costs associated with management of the funding agreement entered into with Indigenous Services Canada.
 → This could include costs for a contractor to perform administrative or management duties if there is not already an employee performing these duties.

20. **Total Expenses** (line 1 to 19)
 → Add together all operating expenses from line 1 to line 19.

21. **Provincial Assistance:** \$ _____ per day for _____ persons x 365 days
 → If applicable, details of funding agreement with the province.
22. **Donations and fundraising and/or funding sources from partners and collaborators**

On-going Contribution Required (on-going annual operational budget)

23. **Line 20 Minus Lines 21 to 22**
 → The required funding from ISC to cover outstanding annual operational costs.
24. **Start Up Costs** (One time expenditures to begin operations, i.e. the goods and services necessary to furnish and setup the facility, including furniture, computers and software, purchase of vehicle, etc.)

APPENDIX 1 –

Capital Items Paid Out From a Replacement Reserve

STANDARD LIST CAPITAL ITEMS

The following is the **STANDARD LIST** of capital items that can be paid for out of the replacement reserve:

A. Major Building Components

- ▶ Roofs, including coating, flashing, eavestrough and downspouts
- ▶ Exterior wall finishes, including exterior painting and stucco exterior doors and windows
- ▶ Exterior caulking where accessibility is a major restriction (e.g., requiring scaffolding) and the replacement is therefore a major undertaking

B. Major Building Services

- ▶ Heating systems, including boilers (hot water or steam), forced air furnaces, radiant heat components, solid fuel burning systems, chimneys and related components
- ▶ Domestic hot water tanks, booster pumps and circulating pumps (fittings and controls replaced during the course of regular, routine maintenance are not eligible)
- ▶ Septic tanks and tile beds
- ▶ Required air handling systems (e.g. HRV systems)

C. Basic Facilities

- ▶ Kitchen facilities such as stoves and refrigerators, sink and faucet installations, counter tops and cabinets
- ▶ Bathroom facilities such as toilets, sinks and fixtures, vanities, tubs and fixtures

D. Safety Features

- ▶ Fire alarm systems such as carbon monoxide detectors, hardwired smoke alarms, smoke and heat detectors linked to central alarm
- ▶ Required firefighting or prevention equipment (e.g. fire extinguishers)

- ## E. Other Major Facilities, Equipment And Features

- ## Regulated Changes

- ## Extensions to the Standard List

If this is the case, the deficiency should be investigated and reported on by a qualified technical expert. The cost of consulting or engineering fees would be eligible for funding from the replacement reserve. Use of the replacement reserve to pay for the cost of replacement or major repair to these items must be approved by CMHC on a project specific basis. In these cases, CMHC may assist in determining the most effective solution and, if necessary, a site visit.

Extensions to the Standard List can include:

- ▶ Repairing foundations or significant sections of foundations
- ▶ Other structural components such as wall, floor and roof framing
- ▶ Brickwork
- ▶ Retaining walls
- ▶ Plumbing systems
- ▶ Electrical installations including project transformers, emergency generators
- ▶ Balconies

Emergency Replacements

Shelters should proceed immediately with emergency replacements of, or repairs to capital items, where delay would create a health or safety hazard. Examples include an essential building system failure, such as failure of a heating system in the winter or a structural failure that endangers the physical safety of the residents.
